MasterGlenium ACE 8109 provides exceptional good early strength development. conventional admixture for high early strength concomitantly suffer from high workability loss over time and eventually lower final strength, MasterGlenium ACE 8109 overcomes this dependency and provides much improved slump retention and vastly increased final strength of concrete.

APPLICATION

MasterGlenium ACE 8109 is a liquid admixture to be added to the concrete during the mixing process. The best results are obtained when the admixture is added after all the other components are already in the mixer and after the addition of at least 80% of the total water

DOSAGE

The normally recommended dosage rate is 0.8 to 1.8 litres per 100 kg of binder. Other dosages may be used in special cases according to specific job site conditions. In this case please consult our BASF Construction Chemicals representative.

PACKAGING

MasterGlenium ACE 8109 is available in bulk and 205L drums.

SHELF LIFE

MasterGlenium ACE 8109 must be stored in a place where the temperature is not below 0°C. In case the product freezes, increase the temperature of the product to 30°C and remix.
